Sundown is at 5:31 P.M. so please bring lighting, preferably solar or battery powered since access to electricity is limited. If you require electricity, you must let us know so we can place you accordingly or inform you ahead of time if we cannot accommodate your request.
- Vendors cannot park in Sun Center parking. For ease of set-up and break down, the best place to park is in the \$5/day dirt lot across SE 2nd Place from Sun Center; that way, you won't have to move your car.
- Vendors must be in place by 2:45 P.M. and remain until the official ending time at 7 P.M. We will provide more information about set-up and break-down as necessary; we must respect area local businesses. Please allow enough time for set-up and break-down. Official hours of Fair are 3-7 P.M.
